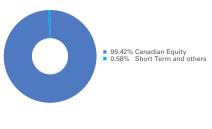

Sector allocation

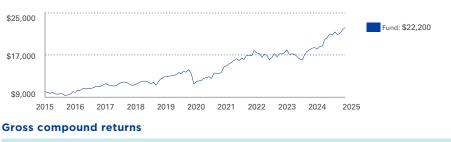
